LIMA TOWNSHIP BOARD OF TRUSTEES REGULAR MEETING MINUTES January 9, 2017

CALL TO ORDER: The meeting was called to order by Supervisor Maier at 7:00 pm. and opened with the Pledge of Allegiance. Present was Supervisor Maier, Clerk Bater, Treasurer Havens, and Trustees Laier and Luick. Also present were many residents and guests.

AGENDA APPROVAL: Trustee Luick moved, supported by Laier to approve the agenda as amended – under Old Business, adding: Discussion of Bike Path. Motion carried

MINUTES APPROVAL: Laier moved, supported by Luick to approve the minutes of the Regular Meeting of December 12, 2016. Motion carried

Treasurer Havens reported that 60% of the property tax bills have been paid with 54% of the money in. 49% of the administration fee has also come in.

OLD BUSINESS:

Ordinance Enforcement of Flags and Yard Signs - Michael Purdy, owner of Catered Coffee at 12855 E. Old U.S. 12, spoke to the Board requesting his business be allowed to display "Flag" signs to encourage more customers and advertise special events. Mr. Purdy stated that he was aware that Dexter Builders had gotten approval for the signs and it was his wish that everyone in the business community be treated the same. The Board asked his desired time frame to display the signs and how many there would be. In response Mr. Purdy was fine with six months and three signs maximum, plus assuring the Board that his signs would always be kept in good shape. Clerk Bater read back the conditions that Dexter Builders agreed to as they would be the same conditions for Catered Coffee: 1) "Flag" (festoon, banner, pennants, ribbons, streamers, etc.) signs be approved for six months, requiring the business to request an extension from the Board; 2) Signs be limited in number; 3) Signs must be kept in good condition; 4) Condition assessment will reside with the Ordinance Enforcement Officer. Other concerns that Board members voiced were that signs cannot flap (make noise), fall over or that Township receive complaints about the flag signs. Moved by Maier, supported by Laier to allow Catered Coffee to display a maximum of three flag signs for a period of six (6) months starting February 1, 2017 and upon review from the Board may be granted an extension. Motion carried with one nay. Supervisor Maier commented to the Board, pointing out that when recurring issues come to the Board and then back to the Board for review it indicates that there may be flaws in the sign ordinance. He requested that the Board think on the issue of whether the ordinance needs changing to add special uses, totally disallow, or remove restrictions all together. Whatever the changes may be, it should correct the process of requests coming before the Board for signs that are becoming much more prevalent for businesses to use.

Bike Path Discussion – Trustee Luick started the discussion by stating that he had much more to say, than the last meeting, now that he is more familiar with the bike path issue. Jeff and David Hardcastle, who spoke about the bike path at last month's meeting, intend to use the Boland railway right-of-way, which runs through Lima Township, for the HWPI. Luick continued to address the meeting by saying that the ten-foot, asphalt, purposed bike path would run in front of many Lima residents homes where there are well-heads and other utilities in the way leaving no front yard for many of these folks and that it is a bad idea for this township. Luick questioned the legality of using the Boland right-ofway since it is over 100 years, the railroad company is out of business, and it was never used for the railroad. Luick read from a document that said if the land is not used for railway purposes for three consecutive years it reverts to the property owners to the south. Luick said he is in favor of something for the bicyclists on Dexter-Chelsea Road and wonders if the road can be widened for a bike path – using the road right-of-way. Many questions were brought up to the Board. Is the Boland right-of-way still a real easement and useable? Is it an abandoned right-of-way? Do the surveyors have a right to be on the land? Is it legal to take someone's land like this? Is it really owned by the Washtenaw County Road Commission? Supervisor Maier also agreed that bikers need space to ride, but he would not want them in his front yard either. Luick stated that this proposed bike path should be studied for further review. Maier said that he would make contact with the Road Commission to see what they have on official file regarding the Boland right-of-way.

Lima Township CAFA At-Large Alternate Board Positon – Supervisor Maier stated that he had spoken with Ron Howdyshell at length and he was extremely interested in the position. He went on to say that Ron would do a very good job representing the Township. Maier moved, supported by Laier to recommend Ron Howdyshell as the Lima Township nominee for the CAFA At-Large Alternate Board Position. Motion Carried
