#2018-03 TOWNSHIP SUPERVISOR 2% SALARY INCREASE RESOLUTION

WHEREAS, pursuant to MCLA 41.95 (3), which provides that in a township that does not hold an annual meeting, the salary for officers composing the township board shall be determined by the township board, and WHEREAS, the Board of Lima Township deems it appropriate to adjust the salary of the Township Supervisor with a 2% increase to ensure that compensation for this position remains equitable and corresponding with the duties of said elective office, now THEREFORE BE IT RESOLVED, that as of April 1, 2018, the annual salary for Township Supervisor, exclusive of assessing duties, will be \$29,973.00.

#2018-04 RESOLUTION TO ADJUST THE SALARY OF TOWNSHIP CLERK

GENERAL APPROPRIATIONS ACT:

FISCAL YEAR 4/1/2018 - 3/31/2019

General Appropriations Act Resolution #2018-08

A resolution to establish a general appropriations act for Lima Township; to define the powers and duties of the Lima Township officers in relation to the administration of the budget; and to provide remedies for the refusal or neglect to comply with the requirements of this ordinance.

The Board of Trustees of Lima Township resolves:

Section 1: Title

This resolution shall be known as the Lima Township General Appropriations Act.

Section 2: Chief Administrative Officer

The Supervisor shall be the Chief Administrative Officer and shall perform the duties of the Chief Administrative Officer enumerated in this act.

Section 3: Fiscal Officer

The Clerk shall be the Fiscal Officer and shall perform the duties of the Fiscal Officer enumerated in this act.

Section 4: Public Hearings on the Budget

For general law townships: Pursuant to MCLA 141.412; MCLA 141.413 notice of a public hearing on the proposed budget was published in a newspaper of general circulation on February 7, 2018, and a public hearing on the proposed budget was held on March 12, 2018.

Section 5: Millage Levy

The Lima Township Board shall cause to be levied and collected the general property tax on all real and personal property within the township upon the current tax roll an amount equal to 0.7957 mills (estimated) as set forth by the Tax Allocation Board

Section 6: Estimated Revenues

Estimated general fund revenues for fiscal year 4/1/2018 – 3/31/2019 shall total \$614,583.00.

Section 7: Chelsea Area Fire Authority Special Assessment

The Lima Township Board shall set aside the Chelsea Area Fire Authority Special Assessment currently set at 1.65 mils as long as the millage is in effect.

Section 8: Estimated Expenditures

Estimated township general fund expenditures for fiscal year 4/1/2018 - 3/31/2019 for the various township activities are as follows:

Section 9: Adoption of Budget by Reference

The general fund budget of Lima Township is hereby adopted by reference with revenues as indicated in Section 6 and activity expenditures as indicated in Section 8 of this Act and Attachment A, dated 3/6/2018, titled Proposed Budget.

Section 10: Adoption of Budget by Activity

The Board of Trustees of Lima Township adopts the fiscal year 4/1/2018 - 3/31/2019 general fund budget by activity. Township officials responsible for the expenditures authorized in the budget may expend township funds up to, but not to exceed, the total appropriation authorized for each activity, and may make transfers among the various line items contained in the activity appropriation. However, no transfers of appropriations for line items related to personnel or capital outlays may be made without prior board approval by budget amendment.
