LIMA TOWNSHIP BOARD OF TRUSTEES REGULAR MEETING MINUTES Monday, May 8, 2017

CALL TO ORDER - The meeting was called to order by Supervisor Maier at 7:00 pm and opened with the Pledge of Allegiance. Present was Supervisor Maier, Clerk Bater, Treasurer Havens, and Trustees Laier and Luick with many residents and guests of Lima Township.

AGENDA APPROVAL - Laier moved, supported by Luick to approve the agenda as presented. Motion carried

MINUTES APPROVAL - Laier moved, supported by Luick to approve the minutes of the regular meeting of April 10, 2017 as submitted. Motion carried

PUBLIC COMMENT –Supervisor Maier opened the public comments by announcing that it appeared there would be many spirited comments, and it would be appreciated if comments were brief and kept to three minutes to accommodate all speakers.

Bill Coltre commended on the nice appearance of the grass at the Lima Cemetery and Hall, and suggested that the same person should cut the Porter Cemetery also. Howard Sias would like money used for bridges and roads rather than for a township hall. Sarah Brooks-Miller spoke about the on-going issue with large trucks hauling material to and from 8786 W. Liberty Road. Bob Spink, and John and Kathie Gourlay all spoke on preserving the Township Hall, and Ron Ruth talked about the problems with keeping the Township Hall.

NEW BUSINESS

Comcast-Michigan Uniform Video Service Local Franchise Agreement Renewal - As part of the Michigan Public Service Commission provision this is a ten-year, Franchise Agreement with Comcast to use rights-of-way within the Townships (METRO Act) for 5% of gross revenue, paid quarterly. The renewal agreement was received by the Township on 5/1/2017 and it must be acted on within 30 days. Moved by Supervisor Maier, supported by Laier to direct the Clerk to fill out the renewal forms, sign and date, and mail the document within the 30 day window. Motion carried.

Medical Marijuana Discussion – Trustee Luick stated that medical marijuana will become legal to grow in Michigan on December 15, 2017 and growers will have to go through the township as part of the legal process. Supervisor Maier added that if the township does nothing, by not adopting any form of an ordinance, all marijuana activities are illegal. He also said that with the Federal and State governments still not in agreement on the law, "I am not for or against it either at this time." Moved by Bater, supported by Laier to table further discussion on medical marijuana pending additional research. Motion carried

Township Hall Ad-Hoc Committee Report – Ed GreenLeaf was absent. Supervisor Maier stated that funds were needed to move forward on either a new hall or renovations to the existing hall. The estimated cost for Midwestern Consulting Engineers to do an initial topographical survey; determine site lay out, which includes storm water requirements, and drain field and detention exploration would be \$17, 818.00. Dangerous Architects would do a spatial requirement and design for office and hall space costing approximately \$10,000.00. There would be a small amount of tolerance build in for unforeseen expenses making the total request not to exceed \$30,000.00. Trustee Luick expressed concern about Midwestern Consulting doing the engineering for the Hall because of problems that occurred with the Construction Agency Building parking lot. Moved by Luick, supported by Bater to table consideration of funding for engineering tests and surveys for the Lima Township Hall until the next meeting. Motion carried
