OLD BUSINESS

Marijuana Discussion – After some discussion it was decided that the Township would continue to be silent on the subject and no ordinance or motion would be made for or against marijuana based on guidance from the Michigan Township Association and reiterated by the Zoning Administrator. Supervisor Maier added that if the township does nothing, by not adopting any form of an ordinance, all marijuana activities are illegal plus the Federal and State governments are still not in agreement on the law and the Township should not be in the middle. No action taken and item is not scheduled for future agendas.

Township Hall Testing/Survey/Engineering Funds Request – Moved by Bater, supported by Laier to accept the bid by Midwestern Consulting dated 5/8/17 for the survey, soil investigation, and conceptual site plan phase not to exceed \$18,000. Midwestern Consulting is Lima Township's customary engineering firm, however it was decided to seek competitive bids. Motion failed **Non-Motorized Pathway** – Supervisor Maier met with Jeff and David Hardcastle on the pathway updates along Dexter-Chelsea Road. The proposed pathway will follow the railroad right-of-way from Freer Road to the Rail Road crossing at the Chelsea Grain Mill. From the Rail Road crossing to Beacon Hill the County is proposing to widen the shoulder 3-4' on both sides - no Boland Corridor will be utilized in this planned area. The County does own a 66' easement through Beacon Hills. A copy of the prints for the new pathway plans have been requested.
