• James Goble's engineer gave a presentation on the purposed Amish structures that will be sold on property.

Western Washtenaw Recycling Authority (WWRA): Nanette Havens

- Material tonnage is down 127,000. Revenues are down \$140,000, while expenses where higher at \$135,000.
- Paper and cardboard lost value. Paper is down \$10/ton and cardboard is down \$5/ton.
- WWRA will start hauling to Arbor Hills which is significantly cheaper than Grainger.
- Manager is conducting employee reviews with 2% wage increases.
- WWRA will be advertising for Special Out Reach Coordinator and Education position

- For the August 7, 2018, State Primary Election, 471 Absentee Ballot Applications were mailed out.

- Meeting with CAFA property owners, Attorneys and Fire Chief on Wednesday regarding sale of property.

- 4-Mile Lake meeting with Water Resources Commission, DNR and Harley Rider, Dexter Twp. Supervisor
 - o Gap in berm (s.w. side) releasing water out of lake, lowering water level below court ordered & customary level.
 - Approximately \$80,000 in repairs are also needed for lift station.
 - o Many residents are renters. 1/3 population is Lima, 2/3 population is Dexter Twp.
 - Property owners are also scheduling a meeting, so when Officials hold their next meeting in August or September, at the Dexter Town Hall, more information will be available and decisions can be made.
- Meeting with new Managing Director of WCRC, Sheryl Siddall, to discuss a number of different topics; US HWY. 12 paving, lack of roadside mowing, scope of future road projects with Township and WCRC, etc.
- Meeting with Township Attorney Lillich & Bateson's Attorney Stringer regarding equipment removal from un-authorized property.
