***CONSULTANT ESCROWS** are required to cover the costs of the Township for outside consulting, (Planning, Engineering, Attorney, etc.). The escrow account will be billed on a monthly basis as consultant fees are incurred. If at any time the escrow account falls below 20% of the initial total, the applicant will be required to make a deposit into the account to bring the balance back to the original total upon notification (unless a lesser amount is determined to be acceptable by the Township). If the applicant fails to replenish the escrow account, then work on the evaluation of the application shall cease, the application shall not appear on any meeting agendas, and the applicant shall be so notified.

The unused deposits will be returned when the project is completed and the fees have been paid in full. A fifteen percent administration fee is to be added to the invoices for consultant fees for all applications requiring reimbursable consultant fees.
