#### Honoring the Service of Judge Richard E. Conlin - Resolution #2019-10

#### Offered by Bater, seconded by Luick

Whereas Judge Richard E. Conlin was appointed to the 14A District Court Bench by Governor John Engler in 1995, and he has served as Chief Judge of the 14A District Courts.

Whereas Judge Conlin has presided at the Chelsea District Court in Washtenaw County, hearing and deciding cases arising in our community.

Whereas Judge Conlin is a long serving member of the Michigan State Bar, as well as the Florida Bar, and has served as a member of the Representative Assembly of the State Bar of Michigan and a member of the Litigation, Probate, Family Law and Real Estate Sections of the State Bar. Born in Ann Arbor, Michigan, to late Honorable Judge John W. Conlin and Catherine Conlin, Judge Richard E. Conlin earned a Bachelor of Arts degree from the University of Notre Dame in 1967 and his Juris Doctor degree from Detroit College of Law in 1975.

Whereas Judge Conlin served in the United States Marines, 1st Marine Division, where he was awarded a Combat Action Ribbon during the Vietnam War.

Whereas Judge Conlin prior to his appointment to the Bench practiced law with the firm of Conlin, McKenney and Philbrick including services to the Catholic Diocese of Lansing in several matters.

Whereas Judge Conlin announced his retirement from the Bench effective October 1, 2019.

Whereas this body deems it appropriate to publically recognize his 25 years' service to this community and its residents and we extend to him and his wife, Jean, our best wishes in retirement and an opportunity free from the cares of office to enjoy their 17 grandchildren.

Now, therefore, be it Resolved, that the Township of Lima honors the service and legacy of Judge Richard E. Conlin to our community.

Whereas since that date changes have been made to the Michigan Freedom of Information Act, Public Act 442 of 1976, MCL 15.231, et seq.,

Whereas section 4, subsection (4) of the Freedom of Information Act (hereinafter "FOIA"), being MCL 15.234, provides in part that A public body shall establish procedures and guidelines to implement this act and shall create a written public summary, and

Whereas the Michigan Township Association (hereinafter "MTA") provides sample FOIA procedures and guidelines, and forms which are all suitable for modification and use by member townships,

Now Therefore Be It Resolved that the Lima Township Board of Trustees adopt the current MTA sample FOIA written public summary, procedures and guidelines, public record inspection procedure, request for public records form, updated itemized fee/cost form, notice to extend response time form, notice of denial form, and appeal of excess fees form and modify them to use as the official FOIA township forms.

Be It Further Resolved that if MTA revises any part of their samples based on changes to the FOIA - Lima Township will also revise all language and forms accordingly.

- Security is very high for this election, i.e., changing passwords and codes practicing for next years' elections.
