OLD BUSINESS:

New motion and approval needed for purchase of office chairs in fiscal year 2021-2022.

NEW BUSINESS:

Zoning Ordinance Text Amendment Resolution #2021-08, Allowing Used Car Sales in Conjunction with Automobile Repair. **Offered by Greg McKenzie, supported Dale Luick.**

WHEREAS an application was submitted on January 21, 2021 by Kern Auto Sales and Service to amend text of the Zoning Ordinance by removing Section 5.7.J. which states "Sales of used cars and other motorized vehicles shall be prohibited,"

WHEREAS Kern Auto Sales and Service has interest in a parcel of land within the Township located at 12671 E. Old US 12,

WHEREAS an analysis and findings report by Carlisle/Wortman Associates, Inc. dated January 15, 2021 was considered by the Planning Commission,

WHEREAS a public hearing was properly noticed and held on February 22, 2021 by the Planning Commission where residents voiced their views regarding the proposed text amendment and proposed Kern Auto Sales and Service future land use, and

WHEREAS following careful deliberation the Lima Township Planning Commission recommends the zoning ordinance text amendment change to allow used car sales in conjunction with automobile repair shops.

NOW THEREFORE BE IT RESOLVED that the Township Board of Trustees, following the recommendation of the Planning Commission, adopt the zoning ordinance text amendment change to delete article #5, Section 5.7, Paragraph J which states; *Sales of used cars and other motorized vehicles shall be prohibited*.

Clerk's Report - Elaine Bater

- Completed the process to get a State of Michigan Vender ID#. This allows the Township to more easily get grants from the State, receive money and it is an additional ID much like a Federal ID#.
- Set up a business account that is government tax exempt with Amazon. Designated people can purchase and Amazon will invoice Township.
- MTA Conference & Expo 2021 is virtual. Attending now is the most cost effective time to benefit from this event because once you are signed up for the conference you have until June to view every offered session of interest and all the material can be downloaded.
- The tapestry quilt is progressing and the new threads being used are very bright colors. Spending a lot of time on researching faded names.

Broad Band Task Force (BBTF) - Duane Luick

- Lima Township has been awarded \$390,800 from the American Rescue Plan Act (ARP) per Barb Fuller.
- One of the ways it can be spent is on infrastructure such as water, sewer or broadband infrastructure.
- All funds must be released to awardees within 15 months, and expended by 12/31/2024.
- Currently there is a fair range of different internet providers used within the Township. Bob Spink suggested surveying residents to compile information on which providers are used, and work best, in what areas so that information can be shared with other Township residents.

Chelsea Area Fire Authority (CAFA) - Craig Maier (absent)

Supervisor's Report – Duane Luick

- The Lima Depot has a rental agreement pending after being shown to many, many people.
- Work had to be done to the upstairs bathrooms to make the house more attractive to potential renters.
- Signing with the new renters is planned for April 15th and the Township will receive the full year's lease payment of \$18,600.00 (\$1,550.00/monthly) in one lump sum payment.
