# LIMA TOWNSHIP POVERTY GUIDELINES 2021

#### **Resolution #2021-10**

**WHEREAS,** the adoption of guidelines for poverty exemptions is within the purview of the township board; and

WHEREAS, the principal residence of persons who, in the judgment of the board of review, byreason of poverty, are unable to contribute to the public charges is eligible for exemption in whole or part from taxation under Public Act 390 of 1994 and Public Act 253 of 2020 (MCL 211.7u); and

WHEREAS, pursuant to PA 390 of 1994 and PA 253 of 2020, Lima Township, Washtenaw County adopts the following guidelines for the board of review to implement. The guidelines shall include but not be limited to the specific income and asset levels of the claimant and all persons residing in the household, including any property tax credit returns, filed in the immediately preceding year;

To be eligible, a person shall do all the following on an annual basis:

- I) Be an owner of and occupy as a principle residence the property for which an exemption isrequested.
- 2) File a claim with the board of review, accompanied by federal and state income tax returns for all persons residing in the homestead, including any property tax credit returns filed in the immediately preceding year. If an applicant or other person residing in the home is not required bylaw to file federal and/or state income tax forms, the attached affidavit must be completed and submitted with the application, (Form #4988).
- 3) Applicant may not have ownership interest in any real estate other than the principal residence.
- 4) Produce a valid drivers' license or other form of identification if requested.
- 5) Produce a deed, land contract, or other evidence of ownership of the property forwhich an exemption is requested if requested.
- 6) As required by PA 390 of 1994 AND PA 253 of 2020, all guidelines for poverty exemptions as established by the governing body of the local assessing unit SHALL also include an asset level test. The applicant's assets may not exceed \$50,000. The following assets shall not be considered when applying an asset test to determine qualification for tax exemption;
  - The value of the applicant's primary residence subject to the exemption.
  - ii. The value of all personal property, such as furniture and clothing.
- 7) Meet the federal poverty income standards as defined and determined annually by the United States Office of Management and Budget. **See Exhibit A**
- 8) The application for an exemption shall be filed after January 1, 2021 but before the day prior to thelast day of board of review.

- 9) If a person claiming the poverty exemption meets all eligibility requirements, the board of review shall grant the poverty exemption, in whole or in part, as follows (See Exhibit A):
- For applicants at or below the 2021 Federal Poverty Guidelines, 100% relieve shall be granted.
- For applicants between 100% and 125% of the 2021 Federal Poverty Guidelines, 50% relief shall be granted.
- For applicants between 125% and 150% of the 2021 Federal Poverty Guidelines, 25% relief shall be granted.
- For applicants above 150% of the 2021 Federal Poverty Guidelines, 0% relief shall be granted.

Applications may be reviewed by the Board of Review without the applicant being present. However, the Board may request that any or all applicants be physically present to respond, under oath, to answer any questions the Board may have.

The following are the federal poverty income standards which the United States Office Management and Budget recommends that federal departments and agencies use. The standards are actually compiled and published by the Bureau of the Census which refers to them as "poverty thresholds."

#### **EXHIBIT A**

# LIMA TOWNSHIP A RESOLUTION TO SUPPORT AFFORDABLE COUNTYWIDE BROADBAND ACCESS

#### **RESOLUTION #2021-11**

At a regular meeting of the Lima Township Board of Trustees', Washtenaw County, Michigan, held at the 11452 Jackson Road, Dexter, MI, on the 12<sup>th</sup> day of July, 2021, at 7:00 p.m. The following preamble and resolution were offered by Elaine Bater and seconded by Dale Luick.

**WHEREAS**, access to high-speed broadband service is critical to the township's mission of supporting the health, safety, wellbeing, quality of life and productivity for all residents, educational pursuits, not-for-profits, medical services, and businesses throughout the township.

**WHEREAS**, access to high-speed broadband for many residents and businesses in the township is unavailable or prohibitively expensive;

**WHEREAS**, since March of 2020, the Coronavirus pandemic has proven the absolute necessity of digital connectivity;

**WHEREAS**, the Washtenaw County Broadband Task Force has taken measures to achieve countywide high-speed broadband coverage; through grant opportunities nearly 66% of the rural county will be digitally connected to high speed internet through the Rural Digital Opportunity Fund (RDOF) program;

**WHEREAS**, approximately 3,700 homes, countywide, will remain unserved after RDOF, a challenge the Broadband Task Force is addressing through the exploration of additional grant and public/private partnership opportunities;

**WHEREAS**, President Biden's American Rescue Plan stimulus funding specifically identifies the construction of high-speed broadband infrastructure as an encouraged use of the funds; and

**WHEREAS**, allocation of ARP funding to incentivize a public/private partnership could close the digital divide that exists in Washtenaw County and bring high-speed internet access to 100% of county residents, regardless of their address, making Washtenaw the first county in the State of Michigan to do so **now therefore be it** 

**RESOLVED** that the Lima Township Board of Trustees, encourages the Washtenaw County Board of Commissioners to allocate ARP funding to a high-speed broadband public/private partnership that serves to connect every home and business in Washtenaw County, thus achieving true high-speed broadband equity and is conducive to the development and implementation of a robust, affordable and sustainable high speed broadband service for Lima Township **be it further** 

**RESOLVED** that Lima Township continues to support the efforts of the Washtenaw County Broadband Task Force in its mission to bring affordable high-speed broadband to Lima Township.
